## **OFFICE MEMORANDUM**

Sub: Guidelines for Batch Testing of various category of agricultural machinery and equipments excluding Tractor, Power Tiller and Combine Harvester and Format for Test Report Number on Final Test Report tested at FMTTIs/FMTCs-reg.

With the approval of competent authority, I am directed to convey the guidelines for Batch Testing of various category of Agricultural Machinery and Equipments excluding Tractor, Power Tiller and Combine Harvester and guidelines for 'Test Report Number' on the Final Test Report tested at FMTTIs/FMTCs. These guidelines will be effective from 01.04.2025.

- I. Guidelines for Batch Testing of various category of agricultural machinery and equipments:
- i. The batch test shall be conducted on the machines, which have already undergone initial commercial test and are being manufactured/sold commercially in the country.

ii. The applicant shall apply for batch testing of the machine at the same test centre where the Initial Commercial Test (ICT) was conducted.

iii. The minimum sample size as applicable vide Ministry of Agriculture & Farmers Welfare, Govt of India OM No. 13-1/2018-M&T (I&P) dated 17.06,2019.

iv. The random selection of test sample may be carried out through online/video call with the applicant.

v. Specifications of model submitted for batch testing, shall be same as reported in the ICT report unless adversely commented upon and/or recommended for change in ICT test report itself.

vi. If the applicant desires to apply for batch testing, he shall apply for batch testing of machine at least 6 months prior to expiry of ICT report.

vii. The subsequent validity of batch test report will be 9 years as per Ministry of Agriculture and Farmers Welfare, Govt of India, O.M. No. 13-22/2020-M&T (I&P) dated 12.12.2023.

yiii. The Test Centre shall conduct all the tests as conducted during initial commercial test on the test sample admitted for batch test.

ix. The validity of batch test report shall be mentioned boldly on the cover page of Final Test Report as well as at inside the report as "THIS TEST REPORT VALID UPTO: day/month/year" before its issue.

**Note:** These batch test guidelines for various category of agricultural machinery and equipments may be read with the conjunction with Test Regulations of the FMTTIs/FMTCs.
